INFORMATION AND GENERAL RULES FOR AROGYA EXPO 2012

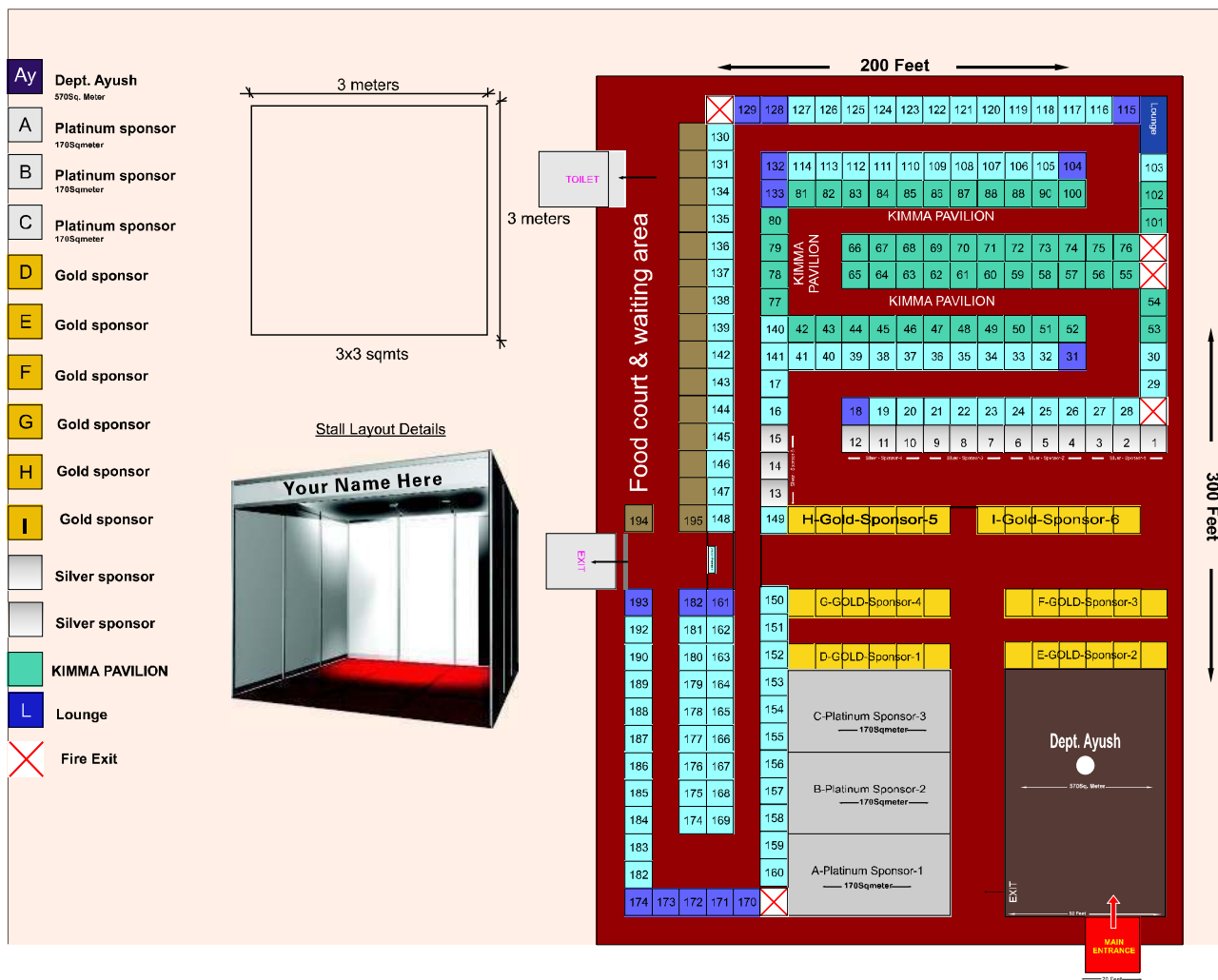
- 1) VENUE : International Conference on Yoga, Naturopathy and Arogya Expo 2012 will be held at Bengaluru, Karnataka, India
- 2) DATE AND DURATION 9th to 13 February 2012
- 3) PARTICIPATION CHARGES
 - a. Rs. 5500/M² + Service Tax (as applicable)
 - b. Standard Stall Size : 9 Sq. Mtrs.
 - c. Deadline for Booking : **15 Jan, 2012**

SPOT BOOKINGS:

To serve you better & with proper facilities & planning, we request not to have spot bookings. Spot booking does not guarantee the particular location of stall & allotment, also depends on availability.

- 4) FACILITIES:
 - 4.1 : Facility for stall shall include structural construction, 3 sides PVC laminated panels, synthetic carpets, fascia in English, 1 spotlight, 1 modular system table, 2 system foldable chairs, 15 amp. Plug point and other basic facilities as in 4.3.
 - 4.2 : The open air space will be without partition, carpet, furniture, electrical fittings etc. (Exhibitors booking bare space are to submit design of the stall to Organizers for approval and this would be by special request only).
 - 4.3 : Basic Facilities available for all exhibitors : General Decoration, Security & Fire Fighting Services in Exhibition Hall, General Publicity for Visitor Promotion, General illumination inside, in the aisles and in the Exhibition Hall. Catering services for Snacks and Lunch in Food Court.
 - 4.4 : Additional Facilities available on payment basis : Electricity for additional lighting and power for demonstration of the equipment, additional furniture spot lights, plug point and other electrical fittings, fixtures, wiring etc. Services of official stand, presentation agency for design, decoration work, display aids stand attendant/interpreter/guides.
Business center facilities such as fax, e-mail, photography, computer services etc. Services of official freight forwarding, handling and clearing agency.
- 5) HANDLING AND CLEARANCE OF GOODS: All clearing and handling of the exhibits shall be the responsibility of the exhibitors However, they can take the help of the official clearing & forwarding agents.
- 6) Exhibitors are required to comply with instructions issued by the Organizers regarding scheduled for setting up and dismantling the stall. Failure to comply with the instructions will attract penalty. A Circular would be issued in this regard to all confirmed Stall holders.
- 7) SUBLETTING: Subletting of stalls is absolutely prohibited.
- 8) GENERAL GUIDELINE: The Exhibitors are liable for payment of compensation for any bodily harm to person, staff, agent, organizers and other Exhibitors and or damage caused to the property of the Organizers and other Exhibitors, caused by himself or his agents during transportation, installation, fair, duration and d'smantling period.
- 9) RIGHTS OF ORGANIZERS:
 - 9.1 To reject any application for space without assigning reason.
 - 9.2 To amend the Terms & Conditions for participation and issue additional rules and regulations for the Exhibitors from time to time which shall be binding on the Exhibitors.
 - 9.3 To recover from the Exhibitors compensation for losses or damages caused to the property or reasonable penalty for any willful contravention of the terms and participation.
 - 9.4 To postpone, curtail, extend or abandon the exhibition or close some or all sections of it temporarily or permanently in unforeseen circumstances.
 - 9.5 To photograph or video film of the interior of any stall and to use the same for promotional work.
 - 9.6 To refuse permission to any exhibitor to clear his stall if he has not paid all dues to the organizers or to retain the exhibits or other goods as collateral security till dues are paid.
 - 9.7 To cancel any booking confirmed or otherwise, with or without payment affected in full or otherwise, without assigning any reason and without any notice or intimation.
- 10) INSURANCE: Organizers shall not be responsible for any loss whatsoever incurred by Exhibitors and they should obtain comprehensive insurance coverage for their exhibits against all risks for the period covering theft, floods, rain, transportation, preparation, installation for fair duration and dismantling including transit and any other loss as such.
- 11) COUNTER SALES: Counter sales are permitted at the exhibition, Exhibitors can sale their exhibits or equipment. In the case of sale, the payment of VAT as applicable to the concerned authorities will be the direct responsibility of Exhibitors.
- 12) FAIR DIRECTORY : Organizers will bring out a Participant's Guide. Entry in the Fair Directory will cover Name & Address of the Exhibitor. Telephone/Fax/Telefax/Chief Executive/Brief details of the products on display, products range manufactured or marketed.
- 13) NON ALLOCATION, CANCELLATION, NON PARTICIPATION:
 - 13.1 If the Organizers cannot allot a stall, money paid by the prospective Exhibitor will be returned. Applicable only if full payment has been made.
 - 13.2 If any Exhibitor withdraws or cancels participation minimum 60 days before the Conference, then only 80% amount will be refunded. This does not apply to part payment.
 - 13.3 If any Exhibitor fails to turn up for the setting up the stall or cancels participation at the last moment, Organizers shall utilize the stall in any manner they deem fit. All the money paid by the Exhibitors will be considered forfeited.
- 14) FORCE MAJEURE: Under the condition of the force majeure which also include strike, lock out, closure, riots, the organizers reserves the right to alter the opening dates and duration or even cancel the entire exhibition. In case of change in dates and duration of exhibition contractual obligations between the Organizers and Exhibitors remain unaffected. In case of cancellation of the exhibition, the stall will be refunded to the Exhibitors after deducting the proportionate costs already incurred by the organizers.
- 15) JURISDICTION: Disputes, if any shall Be subject To Bengaluru, Karnataka, Jurisdiction only
- 16) The application form is to be signed and returned to the Chairman, Arogya Expo 2012, ICYN & AROGYA EXPO Secretariat, Govt. Ayurvedic Medical College Campus, Yoga Hall, Dhanvantari Road, Bengaluru - 560 009. The application must be accompanied with payment by Demand Draft drawn in favour of "AROGYA EXPO 2012"

The organizers reserve the right to deny exhibit of any product, service or message that in their opinion violates applicable laws with no liabilities accruing as a result of such action.
